To whom it may concern :

The body of Mr. Flanagan Devich was sent to Maharaj Nakorn Chiang Mai Hospital on February 19, 1989 and he died on February 20, 1989 at 4:00 pm.

The autopsy was performed on the next morning. The external examination showed laceration wounds at left occipital and abrasion and contusion at the back. I did not find any bullet wound or knife wound or any other sign or mark to indicate violence. The internal examination showed marked brain edema and thin subdural hemorrhage at bifrontal and bitemporal lobes there was multiple skull fracture at left occipital bone and foramen magnum. There was epidural hematoma at fracture site of foramen magnum and compressed cervico-medullary junction.

Cause of death was fracture at foramen magnum and epidural hematoma compressed cervico-medullary junction as it caused respiratory failure.
