Dear Minister

In reference to your letter dated **August 1st / 2006** addressed to me, you have totally missed the point Mr. Minister. The content of my letter to you, was precise and clear, having made sure of touching only matters and events related to what has been nothing, but a «**Fraudulent Handling**» by the P.C.C. of their Investigation on RCMP **Operation Deception**. Therefore, my request to you for the institution of a Public Inquiry under **Section 24 (1)** of the **RCMP ACT**, has absolutely nothing to do with the matter presently before the Superior Court, between me and the Attorney General of Canada in case File no # **500-05-058936-0048**. Furthermore, advising me to address myself to the Attorney General of Quebec is **Illegal**, since he has no jurisdiction from your part. The **P.C.C.** being of **Federal Jurisdiction**, in fact one of many under your **Authority** and **Responsibility** at the Ministry of Public Safety.

In light of the latest events in **Maher Arar's** case, including the «**Forced Resignation**» of RCMP Commissioner Zaccardelli, after having «**Publicly Perjured**» himself several times, I suggest you reading once again my letter to you dated of March / 15th / 2006.

Over the upcoming months Mr. Minister, **Maher Arar's** case will possibly seem to you at some point, as a simple drop of water in the ocean, compared to the **Grossly Dishonest Cover Up**, which the RCMP have made of **DECEPTION** through the **P.C.C.** at the time, with its then **Executive Director**, namely **Ex-RCMP Deputy Commissioner** Bertrand Giroux. I'm asking you to act now Mr. Minister, while the opportunity is given to you to do so. You'll get to hear and see a whole lot of **DECEPTION** over the months to come.
