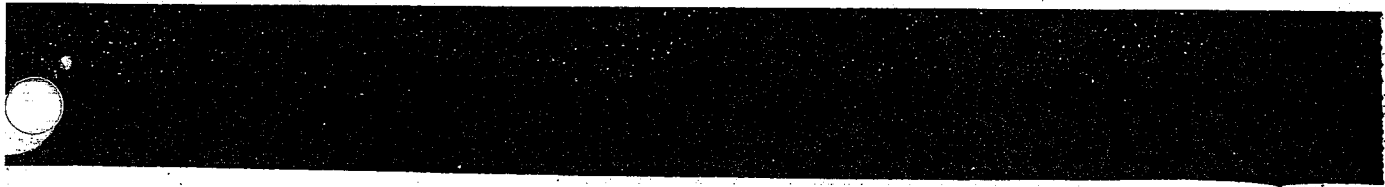

Jim says Barry someone fell out of the truck. He says same at least twice.

We begin yelling for back up.

Amend. Within a few seconds

\* a Thai officer (one of our cover team) was with us. As Jim turned Alain over to Pak - Alain broke away & started to run - Jim & Pak give chase & catch him at gun point - about 50 yards.

Jim & Pak bring Alain over to cell where I have the girl on the road. I take Pak's cuffs & cuff her as she is still fighting. I have Alain on the ground side her with arms behind. Pak takes control of both targets.

Jim again yells for Flan & tells me he saw someone fall out of the truck.

We start to run down the <sup>Munangmai</sup> ~~road~~ Rd from the corner of the alley where the truck exited.

At the distance of 100 metres Jim gets to Flan first & yells it's Flan. I get there & observed

Flan laying on his back showing a large blood loss from the head & ear & eyes open partial.
