You'll find enclosed copy of my letter dated **January / 25th / 2007**, to the Honorable Stockwell Day, Minister of Public Safety.

This present and enclosed letter to the **Minister of Public Safety** was in answer to his letter to my attention dated of **August / 1st / 2006**, copies of which, I'll enclosed for your attention, including for the second time, my first letter to his attention, dated of **March / 15th / 2006**.

Deception was a RCMP's **creation** at the time that the **Conservative Party** was in power in the 80's till earl 90's and it's now back knocking on your door. If such is the case, it's because no one in Power back then and ever since, has dared putting their pants and living up to their **Oath**, not to mention of their **Mandates** and **Legal Duty**, by fear of offending the Righteous RCMP.

Since the **Inception of Deception** in 1987, that the RCMP had been left with the right to act and do as they pleased, without having to fear any interference from the State. In fact, the last 20 years were RCMP's Golden Years. A time, when the RCMP had in two words, * **Total Control** * over the **P.C.C.** in Ottawa. Not really, what **Canadian Taxpayers** do

wish to see happening with their hard-earned dollars. Even more so, when considering the **Mandate** given to the **P.C.C.** by all Canadians, namely to **Honestly Report** of their findings on RCMP's conduct.

The RCMP instead have been allowed controlling the outcome of, who knows how many investigation conducted at the **P.C.C.** over the years? In the case of **Deception**, despite the knowledge of the **Conservative Government**, as well as of the **Liberal's** afterwards, no one dared fulfilling their **Legal Duties** in regard of **Deception**. But the inevitable is catching up on you...

Maher Arar's case, with RCMP Commissioner Zaccardelli's **Forced Resignation**, after **Publicly Perjuring** himself on several occasions to save as a good soldier the troops, is only another example of this. Now, wait seeing what will happen, once the **Wheel of Deception** really starts turning this year.

If anything Mr. Prime Minister, the **Malicious** and **Conscious Mishandling** of **Maher Arar's** case, as an example of RCMP's **Illicit Behavior**, will seem to be a small breeze to you. That is, once compared to the Storm that the RCMP **Cover Up** of **Deception** through the RCMP **Public Complaints Commission** will generate eventually.

Do the inevitable and only one honorable thing to do in regard of my **Request** for the **Institution** of a **Public Inquiry**. Namely, you personally looking into what's s been nothing, but **Deception** at **Canadian Taxpayers'** expenses.
